### 1. Apologies for absence

#### 2. Declaration of Interest

J Maston declared an interest at item 5P (Chairs expenses) as did C Martinson.

# 3. Minutes of the Meeting held on Tuesday 4<sup>th</sup> June 2013

Approved subject to alteration in

Item 5.a.3 should read R Benyon (rather than P) and Item 10.h should read C Martinson (rather than S).

The minutes were otherwise agreed as a true record.

### 4. Matters arising therein

- a) BP Have now paid the amount that was outstanding at the last meeting
- b) Health and Safety Policy had been approved and signed
- c) MMO nothing further has been heard
- d) R Ward stated forms have been completed for the Differential Rating Order and sent off to Minister. We should hear something soon.
- e) ADA had been represented at the Yorkshire Show. R Ward did half a day on their stand. They are planning on being at Driffield Show next year.
- f) Tudor asked if the forms for waste exemption had been completed. R Ward stated the forms had been completed and nothing more had been heard.
- g) R Ward informed the board that at ground tests had been carried out at Sand-Le-Mere and the results were awaited. Gerry Frisby was in charge for the ERYC.

#### 5. a. Maintenance Works

J Maston explained that about 2 months before the harvest began Mick Wilkin had rung him to ask if he should always run starting times through him now he was Chairman. J Maston had asked that Mick still contact the chairs of the previous boards for the go-ahead when works could start. He hoped this was OK with the other board members. A round up of the individual areas

- O Preston J Maston reported that work had started 10 days ago and is ongoing.
- o Thorngumbald M Cook reported no sign yet. J Maston suggested chasing M Wilkin up.
- Keyingham C Martinson reported that this area was nearly completed except for Burton West and Braemar

- Ottringham T Williams reported 2 machines down there and a good stretch of the main drain done. Rest is ongoing.
- Winestead P Stephenson reported that K Adds had started at Nettletons bridge to Booster Pump and more work may be needed to get weed out. R ward reported that EA had a 360 digger and a JCB at Booster Pump.
- Skeffling G Lount reported work had started at Welwick to Skeffling Pump.

### Keyingham and Winestead Main Drains

J Maston informed the group that after a lot of hard work by Graham Stuart, and in the clerk's office and by board members for site visits etc 6 sites across England were chosen for a pilot scheme. Keyingham and Winestead are one of them. J Maston is very aware that whilst board members understand what is happening, members of the public may not so Richard Babbington is putting a piece in the Gazette which will explain what is happening with amalgamation, maintenance and hinting at changing the boundaries. The agreement has now been signed for the following

- i. Keyingham Drain Bush 1 bank, Weed 1 bank, silt bottom of ditch between Stony Creek Keyingham Clough to Junction of Keyingham Main Drain and Ryehill. This will be financed by monies raised from increasing the drainage rate for Keyingham by 16p and part of the £11,000 from Environment Agency. This will cost approximately £20,000. Turners are doing the first section and M Wilkin will follow and weed. As this is a Pilot scheme everyone will be watching and so it needs to be done correctly. M Jackson asked if this included the price for the gates and fence. R Ward stated there was a bit in for fencing but M Jackson stated it would be quite a lot of work. R Ward to talk to Macfarlanes, Ian Cox and Taylors. Also Jack Clappison had not given permission yet. Wielopskies, De-Langs and Buckle and Sands Farm would be the worst bits for trees. M Cook felt Round-up following on from this work would help save money in the future. H Sadler stated that when the drain was cleaned out Stone Creek Drain was 18inch lower than ever but before the rain started it had gone up to the existing level. It is touching the bottom of the bridge in his 70 Acre and it normally only does that in extreme weather conditions. The members discussed the dry summer, neglect of over 20years and the need to keep checking on levels.
- ii. Winestead Drain Bush 1 bank, Weed 1 bank, De-silt bottom of ditch between Barr House Bridge and A1033 Bridge and weed between A1033 Bridge and Winestead Outfall Pumps. R Stephenson felt there was not as much bushing in this area. These works will be done by M Wilkin and cost in the region of £14,000. This includes a ramp at Whitehall. R Ward will go tactfully with this. P Stephenson stated that the bank at Bar House is in a bad way and caution should be taken.

J Maston asked if P Turner had any comments. P Turner stated that he felt if this pilot was a success it could be built on over the coming years.

M Jackson asked if the £11,000 from the EA would be a yearly figure. R Ward did not think it was.

### b) Health and Safety

No reported problems. The Policy is now signed by J Maston and R Ward

### c) Correspondence

ERYC (Chris Matthews) still want to keep control in towns, villages and works. Discussions are still happening as to how it will affect the rates financially. R Ward will continue to investigate the effect it will have on the rates.
