An introduction of the ERYC Flood Alleviation Scheme for Bilton was presented by the Guests which included:

2 attenuation Lagoons Discharging into Old Fleet

2 pumps at Lords Clough Discharging into The Humber

A discussion took place on this. The Chairman asked the ERYC as to who is to maintain the culvert who is to maintain and operate the attenuation lagoons and who is to run and maintain the pumps.

- 6 Maintenance

Skeffling – Pumps have worked well, very few problems 2 new culverts blew and the contractor took them out and resolved the issue.

Winestead - Problems with the weeding not being done on the EA sector. Could not run pumps until Saturday and Sunday as they were turned off. Andrew Wilkin managed on Monday to get a flow going. EA changed levels on booster pumps to get on automatic, 2/3 pumps now running Ottringham — Monday the digger cleaned one side and got a flow, was a small flood in the village but nearly all done. The door was blocked and Tudor cleared it and is now working.

Keyingham - Maintenance up to Roos Bridge / Owstwick split, Andrew Wilkin is going back to finish, as a lot of water has gone back in today but will blitz this week H Sadler noted the doors were not operating correctly. The Clerk had reported this to the EA.

Thorngumbald – Pump needs cleaning out and the Newton Garth Drain to the bypass to be finished off.

Preston New Drain/Reedmere - digger is in today at the Pensana site to clear, most is done at Saltend and permissions were granted to go on site.

Old Fleet – The clough/ABP has not been cleared at Lord Clough. Flooding on field and into the school, reported to EA and they are using 2×8 " and 1×6 " pumps. Cleaned up to the railway culvert but now needs a big digger from there.

General comments on maintenance: -

6A. <u>Indication</u> of issues with EA as could not get hold of anyone at the weekend. Monday response was good. Guy wants a meeting with the EA to debrief as this is a time period when we could possibly train new members to control locally. EA control room is in York and we need a direct line to this office.

Andrew Wilkin had concentrated on EA Drains, where housing may flood rather than the drains clearing arable land.
